childhood higher education opportunities. Our work will create more seamless educational pathways for		
early childhood student access and success, benefitting not only the students but leading to a strong, well-		
qualified workforce to better support providers and employers in the state, young children and families in		
their care, and the broader workforce generally.

Principle 1: Center Student Success		
The first priority of the Consortium is student success.		
• The Consortium serves early childhood higher education students at all levels and institutional settings.		
 <u>Consortium members acknowledge and seek to address historical and current barriers to degree</u> completion and licensure.

• The Consortium gives priority focus to meeting the needs of the incumbent early childhood workforce.		
Principle 2: Share Leadership		
 All members contribute to and benefit from the Consortium. 		
These Principles are the foundation for Consortium policies.		
• Consortium governance is shared at all levels (administrators, faculty, etc.)		
 Decisions are made considering the interests of students, employers, and all other stakeholders. The Consortium is a learning community, a forum for creative problem solving and innovative solutions. 		
 The consortion is a rearing community, a roran for creative problem solving and innovative solutions. We strive for agreement through consensus building.
