I. Welcome, Housekeeping, and Opening Remarks

While participants were logging into the Zoom meeting platform, a slide asked participants to add a response to the following question: "Please share something interesting or exciting happening in your program." The answers gleaned from the chat box can be found in Appendix 1 of this document.

II. Minutes: Review and Approve

The minutes of the October 27, 2023, meeting were unanimously approved without corrections. Kate Connor moved to approve, and Johnna Darragh-Ernst seconded.

III. Opening Remarks Cont'd.

Marcus Brown from ICCB provided an overview of the data found in the mid-year report published January 2024, containing leading indicators of progress including the following data points:

•Illinois institutions are actively engaging and recruiting EC workforce members and employers with more than 1700 outreach events in the AY23 which involved more than 26,000 workforce members and more than 6000 employers were involved in some way.

•The navigators have been very productive assisting current or potential scholarship recipients with over 79,000 emails for outreach or technical assistance; 7,720 phone calls; 1,209 information sessions; 1,092 meetings with employers for outreach; 4,9249 meetings for technical assistance and 802 meetings with colleges and universities. These numbers are growing every day!

He then shifted to look at the next annual report targeted to be released late Spring, 2024, which will focus on: Enrollment, persistence, and completion of incumbent workforce; Outreach and participation of the early childhood workforce and employers; Keeping student loans out of the funding as much as possible; Responsiveness of needs of employer and workforce; Consortium budget; and Institutions' work to support students. The work may also be able to pursue goals that were set out three years ago including data sorting and data matching which is not a simple process but hoping to include it in the future reports.

Brown shared that on July 1, 2024, legislation was introduced to establish a new Illinois Department of Early Childhood to help the public have one place to go to rather than multiple agencies. The Transition Advisory Council was formed including representatives of families, providers, and others to help form this new Department.

Additionally, Brown shared that changes to the ECACE Act that have been proposed include: ECACE Advisory to provide guidance on Consortium operations with the GOECD appointees now to be appointed by IDHS until the new Department of Early Childhood can pick this up. Also, it proposes to go from four meetings per year to two meetings per year and from two reports per year to one report per year. The proposal removes language from the legislation regarding regional hubs. It also adds ECACE Scholarship to the statute.

IV. Consortium Work: FY25 and Beyond

Brian Durham discussed the Governor's Proposed ECACE Budget for FY25, which included \$5,000,000 for the ECACE Scholarship proposing the use of state funds rather than the federal funds used. He discussed next steps in the budget process for Illinois and highlighted the following specific items:

- Higher Education Operating Budgets: 2% (\$30.6M) increase to public universities and community colleges.
- Other Scholarships: Maintenance of Minority Teachers of Illinois, Golden Apple and Gateways Scholarships
- Smart Start: \$75M increase in ECBG (e.g., Preschool for All and other programs to address preschool deserts by increasing 5,000 seats, which will mean additional teachers needed)
- \$200M in funding for Early Childhood Workforce Compensation Contracts

Durham provided an opportunity for Questions from the participants and the following questions were asked:

Q: Lyndsey Meeker: Question about the \$5M for scholarship. Is it just for student scholarship or other things?

A: Durham: Student scholarships are only use of the \$5M.

- Q: Will navigators be involved in the new EC Agency under their funding?
- A: Durham: Not sure, but a good question to ask in the future.

Q: In the chat: Who will get the new scholarship monies?

A: Brown: prioritizing renewals with revised guidelines.

Christi Chadwick of IBHE shared the Consortium next steps. She encouraged all to step back and look at the original vision which was developed by working groups that developed the idea of the Consortium to help institutions and partners to work together. The original vision was and still is: "Collectively and individually address opportunities and barriers for the early childhood workforce to access, persist, and complete credentials and degrees." The purpose of the Consortium was to work together as a collective group to streamline, coordinate, and improve accessibility and completion of degree pathways, while advancing equity using:

- Systems responsive to EC workforce needs
- Accessible programs, pathways, and supports
- Transfer without credit loss

- Coursework at multiple institutions without the hassle of navigating both systems
- Recognizing competencies knowledge, skills, and abilities of the incumbent workforce
- Flexible and personalized paths to completion and credit for prior learning
- Access coursework when and where it is needed—not limited by geography, time, and format.

Brown led an activity using Padlet where the question, "What can your institution continue to provide beyond this year?" was asked. A variety of answers including course flexibility; student support; transforming the system that supports the workforce; persistence; completion; supporting better salaries/wages for workforce; how to better partner with employers at large; etc.

V. Working Group: Creative Course Delivery

Chadwick shared that IBHE is launching a working group for 2- and 4-year institutions to think about how we might work together after June 30 to provide support and accessibility to Consortium programs. Meetings will kick off on March 15 with meetings every two to three weeks for about 90 minutes (about 1 and a half hours) on Fridays and virtually, with time to be determined. It is open to two- and fouryear institutions and those from various roles including faculty and administration. The working group members should be selected by the institution team. ECACE will send out an email/survey for those interested in participating. Time was provided for questions and no questions were posed.

VI. Communications: Building the EC Workforce

Zach Allen from the Illinois Department from Human Services Division of Early Childhood and Rebecca Livengood from INCCRRA provided an overview of a soon to be released Communications Campaign to promote career opportunities in ECE. Meeting participants reviewed live versions of advertising used in various formats and locations.

VII. Public Comment

Maya Portillo, Senior ECE Policy Advisor at Advance Illinois, commented on the work of the ECACE Consortium. Below is a transcript of her comments:

I want to start by thanking the agencies, higher education institutions and all other stakeholders here today for their exceptional leadership in standing up ECACE. In a timespan of just 2 short years - your commitment to increasing both access and completion to higher education degrees and credential programs for the early childhood workforce has been extraordinary and your work has not gone unnoticed.

In the recently released mid-year report, it was noted that 3,900 students and counting, representing 95% of Illinois counties have benefitted from the scholarship – that's remarkable!

And – not only have programs prioritized access and enrollment, but mentors and others within institutions have prioritized persistence and completion – which is key for our working students.

Indeed, beyond scholarships, we recognize the many other necessary components of this program that to date has made ECACE so successful including the support of the consortium higher education institutions, the mentors, the navigators, and so many others.

I am here today as an advocate for ECACE and to express Advance Illinois' deep concern over the recently released governor's budget proposal. We see this as a missed opportunity to build on the momentum that has been created here, and a serious one at that. We recognize the real impact ECACE

is having on the lives of the candidates served by the program and on future early childhood programs, centers, classrooms, and children and families.

The Governor and the state have laid out ambitious early childhood plans – plans we applaud. But we cannot effectively advance the State's Smart Start Illinois plan to achieve universal PreK by 2027 without ongoing and sustained investment in our early educator pipeline and workforce. The one rests on the other – making ECACE essential.

So, this legislative session, we will be asking the General Assembly to sustain funding for this program – and do so at a level that maintains support for current scholarships and infrastructure as it looks to expand its impact – ideally the full \$60M required to run the program at the scale and with the depth required.

Once again, thank you for the immense work that has gone into making this program so undeniably successful. We will continue to advocate to ensure this program has the opportunity to continue to be so successful and make a real impact on the lives of the EC workforce, children and families of Illinois.
